


USD 237 Therapy Dog

With the help of the Smith County Community Foundation, SCE was able to purchase a Cavapoo puppy from a registered breeder and have the puppy trained to be a therapy dog.

Selah the Cavapoo responded very well to her training and was welcomed into the classrooms at SCE. "Seeing Selah work with children who suffer from mental health issues is amazing. She can sense when love and comfort is needed as well as when it's play time. Selah even helps read to the kids and gravitates to the ones that are in grave need of her''', said Katie Grabast of Smith Center Elementary.




MATCH MONTH SUCCESS

NWKansas GIVES

NW Kansas Gives is an initiative through the Dane G. Hansen Foundation to capture the significant transfer of wealth in its 26-county service area. According to a study with the Keep Five in Kansas Campaign, between 2020 and 2064 it is estimated that nearly \$30 billion will transfer from one generation to the next in Northwest Kansas, with \$1.4 billion in Smith County.

We are partnering with the Dane G. Hansen Foundation to encourage people like you to consider leaving a portion of your estate to the Smith County Community Foundation in a permanent fund to benefit your community forever. If just five percent of the \$1.4 billion, or \$70 million was captured in a permanent fund, it would generate nearly \$3.2 million in annual grants to support causes in Smith County.
